**PUBLIC SAFETY POWER SHUTOFF ENGINE NOTIFICATION FORM**

If you want to connect and/or wire a portable engine powering a generator to a building before you actually lose utility power without getting a Yolo-Solano Air Quality Management District (District) permit, you must do the following:

- Use an engine that is EPA certified
- Use an engine that has a valid Portable Equipment Registration Program (PERP) registration, or you must have completed and submitted a [Form 40](#) to the Air Resources Board (ARB)
- Submit this notification form to the District at [notify@ysaqmd.org](mailto:notify@ysaqmd.org)

The District will allow the above described use of a portable engine without a District permit for calendar year 2020 – if you anticipate wanting or needing to use an engine to power a building in 2021 or beyond, you are required to obtain a District permit ([permit application](#), [supplemental form](#), and [fees](#)) before you install the engine.
