Applicants for an initial Authority to Construct (ATC) must pay the filing fee listed in Section 307 (Schedules 1–8) of Rule 4.1 when submitting their application. If the District determines that fees should be based on actual hours worked, the filing fee will serve as a deposit per Section 307.10. For PTO renewals, permittees must pay the applicable annual fee (Schedules 1–8) and any emission fees outlined in Section 302.2.
